(B) e-Auction OPENING AND EVALUATION OF e-Auction

1. Evaluation of technical e-Auction and Evaluation Criteria
2. The Seller will examine the e-Auction to determine whether they are complete, whether they meet all the conditions of the Contract, whether required e-Auction fee, e-Auction EMD and other required documents have been furnished, whether the documents have been properly digitally signed, and whether the e-Auction are generally in order. Any e-Auction or e-Auction not fulfilling these requirements shall be rejected.
3. The Participants shall submit the scanned copies of following as documentary proof for evaluation of their technical e-Auction:-
4. The Participant shall upload the copies of the detail of E.M.D. The e-Auction submitted without required documentary proof shall be rejected.
5. The Participant shall submit the copies of the details of Aadhaar no. and PAN no. self attested. The e-Auction submitted without required documentary proof shall be rejected.
6. The e-Auction found to be not responsive to and not fulfilling all the conditions of the contract and not meeting Technical Specifications and Qualification Requirements to the satisfaction of Seller shall be rejected and may not subsequently be made responsive by the Participant by correction of the non-conformity.
