### **(A) THE AUCTION DOCUMENT**

#### **1-Cost of e-Auction**

- 1) The Participant shall bear all costs associated with the preparation and submission of its e-Auction and U.P. Co-operative Sugar Factories Federation Ltd, Lucknow hereinafter referred to as “the Seller”, will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the e-Auction process.
- 2) This Auction document is available on the web site <http://eAuction.gov.in> and [www.upsugarfed.org](http://www.upsugarfed.org) to enable the Participants to view, download the e-Auction document and submit e-Auction online up to the last date and time mentioned in e-Auction notice/e-Auction document against this e-Auction. The Participants shall have to pay e-Auction document fee of **Rs 2360.00 (Rupees Two Thousand Three Hundred Sixty Only)** through **RTGS/ NEFT/ NET BANKING** payable in favour of U.P. Co-operative Sugar Factories Federation Ltd, Lucknow. The scanned copy of the **RTGS / NEFT/ NET BANKING** must be uploaded along with the e-Auction before opening of the technical e-Auction. This e-Auction document fee of Rs. 2360.00 will be non-refundable.
- 3) The price of Molasses (ex-Sugar Mill). The rates should be quoted net and other taxes and duties shall be payable by the buyer as applicable / prevailing at the time of lifting of molasses.  
(a) Rate of Molasses (Rs per quintal). The rates should be quoted net and other taxes and duties shall be payable by the buyer as applicable / prevailing at the time of lifting of material.
- 4) **e-Auction Currencies**  
  
Prices shall be quoted in Indian Rupees only.
- 5) **e-Auction Earnest Money Deposit (EMD)**  
  
The Participant shall furnish, as part of its e-Auction, an e-Auction EMD of Rs 20.00 (Twenty) per quintal) in the form of **RTGS/NEFT/NET BANKING**, in favour of U.P. - 7) The successful Participant’s e-Auction EMD will be refunded after the timely Lifting of Molasses & submission of duly verified MF-4, Gate pass of Mill and satisfactory lifting report from respective factory.
- 8) **Period of Validity of e-Auction**
  - 8.1 e-Auction shall remain valid for lifting of molasses for 30 days from the date of issue of sale order in case sale made within State and 45 days from the date of issue of sale order in case of outside Uttar Pradesh.

- 8.2 The validity can be extended by the Managing Director Federation on reasonable ground with the condition that if the higher rates of Molasses (Free & Levy) are received by Federation for the concerned unit the same shall be applicable for lifting the balance quantity of extended period.

**(B) e-Auction OPENING AND EVALUATION OF e-Auction**

- 9 Evaluation of technical e-Auction and Evaluation Criteria
- 9.1 The Seller will examine the e-Auction to determine whether they are complete, whether they meet all the conditions of the Contract, whether required e-Auction fee, e-Auction EMD and other required documents have been furnished, whether the documents have been properly digitally signed, and whether the e-Auction are generally in order. Any e-Auction or e-Auction not fulfilling these requirements shall be rejected.
- 9.2 The Participants shall submit the scanned copies of following as documentary proof for evaluation of their technical e-Auction:-
- 9.3 The Participant shall upload the copies of the detail of E.M.D. The e-Auction submitted without required documentary proof shall be rejected.
- 9.4 The Participant shall submit the copies of the Authorisation letter by the Managing Director for the authorised person. The e-Auction submitted without required documentary proof shall be rejected.
- i. Name .
  - ii. Designation - If Company employee
  - iii. List of member of director to be submitted for verification of signature of authorised person if person is not employee of Distillery/ Company. The e-Auction submitted without required documentary proof shall be rejected.
- 9.5 (A) If Participant is a proprietorship firm or registered firm, then copy of registration from Registrar of firms along with partnership deed/GST certificate to be submitted.
- OR
- 9.6 (B) If the Participant is a company then copy of certificate of incorporation issued by the Registrar of companies of the state along with memorandum of article of association.
- 9.7 The Participant shall submit the copies of the details of GST registration and PAN no self attested. The e-Auction submitted without required documentary proof shall be rejected.
- 9.8 The e-Auction found to be not responsive to and not fulfilling all the conditions of the contract and not meeting Technical Specifications and Qualification Requirements to the satisfaction of Seller shall be rejected and may not subsequently be made responsive by the Participant by correction of the non-conformity. The e-Auction of Participants mentioning any of their conditions which are not mentioned in the e-Auction document or are not in conformity with the conditions of the contract shall be rejected.

- 9.9 It shall be the discretion of the Seller to decide as to whether an e-Auction fulfils the evaluation criterion mentioned in this e-Auction or not.
- 9.10 The Participants are advised not to mix financial Auction documents with the PDF documents submitted for technical Auction. The e-Auction of the Participant having financial Auction document in the technical Auction will out rightly be rejected.
- 9.11 The commercial quotes of the Highest Participant (H-1) shall be eligible for purchase of Molasses. The Quantity offered by the H-1 shall be first taken into consideration.
- 9.12 The Participants are required to give their maximum rates in the Auctions though generally negotiation will not be held.
- 9.13 In case H-1 offers partial quantity for lifting then balance of the quantity shall be allotted to subsequent Participant(s) provided the successful Participant(s) are ready to offer the rates quoted by H-1.
- 9.14 In case H-1 backs out, the Auction shall be cancelled & Auction shall be invited again. H-1 shall however be blacklisted from participating in any future auction of Molasses in Sugar Federation and are liable for legal action taken by UPSUGAR FED.
- 9.15 The Participant shall submit the copies of the details of PD2 licenses and any relevant documents issued by the Excise Authority of State and other State in case of Export.

## **11 Contacting the Seller**

- 11.1 Participant shall contact the Seller on any matter relating to his/her e-Auction, from the time of the e-Auction opening to the time the Contract is awarded. If the Participant wishes to bring additional information to the notice of the Seller, he/she can do so in writing.
- 11.2 Any effort by a Participant to influence the Seller in its decisions on e-Auction evaluation, e-Auction comparison or contract award may result in rejection of the Participant's e-Auction.

### **(C) AWARD OF CONTRACT**

## **12. Award Criteria**

- 12.1 The Federation will award the contract to the highest Participant (H-1) successfully Participant whose Auction has been determined to be responsive to all the conditions of the contract and meeting the technical specification and qualification.
- 12.2 In case H-1 offers partial quantity (offered) of lifting then balance of the quantity shall be allotted to subsequent Participants provided the successful Participant are ready to offer the rate quoted by H-1.

## **13 Seller's right to vary Quantities at the Time of Award**

- 13.1 The seller reserves the right at the time of contract award to increase or decrease the quantity specified in the schedule of MultiLot Sheet without any change in unit price or other terms and conditions, depending upon the requirement of respective sugar mills.
- 13.2 If any taxes/duties are increased/ decreased by the Government during the contract period, the same shall be borne by the buyer.



**14 Notification of Award**

14.1 Prior to the expiration of the period of e-Auction validity, the Seller will notify the successful Participant in writing by letter/e-mail/fax, that its e-Auction has been accepted.

14.2 The notification of award will constitute the formation of the Contract.

## SECTION II: CONDITIONS OF CONTRACT(CC)

### QUALITY

The Molasses is being sold on the as is where is basis.

In Case of delay in lifting beyond control of the buyer the validity period may be extended after reviewing the situations with necessary documentary evidenced by the Managing Director U.P. Co-operative Sugar Factories Federation Ltd.,

#### 1. EARNEST MONEY

Each Auction shall be accompanied by an earnest money of Rs.20.00 per quintal (Rs. Twenty per quintal) in form of the RTGS / NEFT/ NET BANKING in favour of U.P. Coop. Sugar Factories Federation Ltd., payable at Lucknow. The Auction without earnest money shall be liable to be rejected. No interest shall be payable on the earnest money.

#### 2. PAYMENT

The payment shall be made in advance through RTGS/NEFT/NET BANKING before the lifting. The payment against the cost of Molasses should be made in favour of U.P. Co-operative Sugar Factories Federation Ltd. and the payment for duties and taxes shall be made through Bank draft in favour of concerned unit.

#### 3. ARBITRATION :

Solely for the purposes of settlement of any dispute arising between the parties out of this agreement, the contractor shall be treated as an agent of the mill and any dispute arising out and between the parties to this agreement shall be referred to arbitration to the Registrar in accordance with Section 70 of the U.P. Cooperative Societies Act, 1965.

#### 4. GENERAL CONDITIONS :

- 1 प्रत्येक क्रेता के द्वारा उठान आदेश में निर्दिष्ट भुगतान की शर्तों के अनुसार सम्बन्धित इकाई से शीरा उठान के लिए शीरा मूल्य इकाई में अग्रिम जमा किया जायेगा।
- 2 प्रत्येक निविदादाता को निविदा के साथ धरोहर धनराशि अग्रिम रूप में नियमानुसार उ०प्र० सहकारी चीनी मिल्स संघ लि०, लखनऊ के पक्ष में आरटीजीएस/नेफ्ट/नेट बैंकिंग द्वारा जमा करना आवश्यक होगा। धरोहर धनराशि की दर रू० २०/- प्रति कु० याचित मात्रा में होगी।
- 3- (अ) निविदादाता यदि शीरे के क्रय आदेश एवं निविदा शर्तों के अनुरूप कार्य करने में विफल रहता है तो व्ययगत मात्रा की समानुपातिक धरोहर धनराशि जब्त करने का अधिकार सहकारी चीनी मिल्स संघ के पास सुरक्षित है। विक्रय किये गये शीरा मात्रा में से एक टैकर (१५० कु०) से कम शीरा लैप्स होने पर शीरा क्रेता की कोई धरोहर धनराशि जब्त नहीं होगी, किन्तु एक टैकर (१५० कु०) या इससे अधिक मात्रा लैप्स होने पर शीरा क्रेता की धरोहर धनराशि नियमानुसार जब्त की जायेगी।
- (ब) क्रेता द्वारा उठान न किए गये शीरे को यदि संघ द्वारा घटी दरो पर विक्रय करना पड़ता है तो ऐसी स्थिति में क्रेता की सम्पूर्ण जमा धरोहर धनराशि जब्त कर ली जायेगी।

- (स) निविदादाता के द्वारा आदेशित शीरा मात्रा का सम्भरण न किये जाने की स्थिति में प्रबन्धतन्त्र के द्वारा परीक्षणोपरान्त प्रतिकूल तथ्य दर्शित होने की दशा में काली सूचिबद्ध करने का अधिकार सुरक्षित रहेगा।

- ५- प्रत्येक निविदादाता द्वारा आबकारी आयुक्त एवं शीरा नियंत्रक उ० प्र० के द्वारा निर्गत आदेशों के अन्तर्गत रसायनिक उद्योग आसवनी तथा पंजीकृत औद्योगिक इकाई द्वारा बोनाफाईड वास्तविक शीरा उपभोक्ता होने का प्रमाण पत्र दिया जायेगा, जो शीरा क्रय करने की पूर्ण अर्हता रखता है तथा भविष्य में इस सम्बन्ध में उत्पन्न होने वाली किसी भी विवाद में विक्रेता किसी भी प्रकार से उत्तरदायी नहीं होगा।
